2 Hotels

In newsletter 2 we have said about the hotels in Amsterdam that the best way of booking a room is to use a website like www.booking.com and www.hotels.nl. But we have contacted one of the hotels in the neighbourhood of the venue, and have asked the hotel management about the possibility the offer rooms for a special price – also for people from outside the Netherlands. We did succeed... not so many rooms, but we hope to help in this way some participants. Here below you find information about this hotel - and also another hotel, not far from the venue (without a special discount for participants, but the prices are still okay, we think).

WestCord Fashion Hotel

This hotel is about 12 minutes from the venue (just a small walk and a few minutes by tram). We have made an arrangement for 15 rooms.

- Room, single use, including breakfast: 125 euro
- Room, double use, including breakfast: 142 euro

These prices are fixed for the 17th and 18th of June. If rooms are needed and also available for the other nights, the management has promised to use the same prices or to look for the best available prices. That's why we recommend sending an e-mail to fashion@westcordhotel.nl with details about your stay in the hotel – mentioning the group code: GF992.

If this is a problem, you can use the website of the hotel, mentioning the group code (groeps-code): GF992.

Like we have said, we recommend you not to wait too long, looking at the number of rooms for those prices. The hotel offers of course more rooms, with (much) higher prices.

Tulip Inn Amsterdam City West

This hotel can be found in Amsterdam-West, just 800 meters from De Meervaart – this takes a walk of 10 minutes.

You can book a room, without using a code, on www.booking.com. Or on the website of the hotel: www.tulipinnamsterdamwest.nl.

Prices are at the moment:

- App. 90 euro per night, without breakfast
- App. 76 euro per night, without breakfast, 'non-refundable' !!

The number of available rooms is not so high, so don't wait too long with your booking.

Other hotels

As mentioned before, use booking websites to find other hotels in Amsterdam Centre – having in mind that you can go by tram 1 or tram 17 to the venue.

For instance, there is an IBIS hotel next to Amsterdam Central Station (app. 135 euro, including breakfast, non-refundable!).
